CHAIRMAN

EXECUTIVE ORDERS

Effective 16-04-2009 the “Transitional Government of Eritrea” have declared that the Government of Dictator-president Isayas-Afewerki of Eritrea is Null and Void (Invalid).

So, from 16-04-2009 onwards no one should obey (accept) order issued by Dictator-president Isayas-Afewerki.
